## July 2006 Update

Thanks to the efforts of Cathy Cooper, HEW (<a href="www.hew.org.uk">www.hew.org.uk</a>) and every one of us who objected or commented to Richmond Council on the last application to demolish the Victorian buildings at the end of Hamilton Road and replace them with flats and offices, the planning application was, as you may already know, turned down.

This is not the end of it however, and the developers have informed us that they intend to put forward a further proposal. They have not done this yet, but when they do it is up to us as local residents to try and stop it if we do not agree with what they propose.

That means doing exactly as we did before, if possible in greater numbers, and writing or emailing our objections to Richmond Council's Planning Offices. If you commented last time then the same reasons can be used, or if you are new to the road, didn't comment or there is a significant change in the developer's proposal, new reasons may be appropriate. What is important is that we all actually **do it**. All of us are busy, and have many many other things that take up our time, but it is vital that we stay involved in this. These are our streets, our homes, and it is our immediate environment that will be affected.

Cathy, Ruth T and Pandie, amongst others, are continuing to keep up with the developer's plans, the councils movements and generally keeping the interest going. You can help out by contacting any of them on the address below, either by email or by or returning the tear off slip, and letting them know you are still interested in this campaign

As soon as a plan is submitted we propose holding a residents meeting to agree the next steps. We had over 50 people at the first one of these - lets try and make it 100 at the next one.

Other current planning applications that will affect us (e.g. traffic build up, parking problems, unsightly buildings, an increase in the density of the local area etc) are in Norcutt Road (06/2018/FUL), and Gould Road (06/2033/FUL).
